CIRCULAR

Re-Constitution of Anti-Ragging Squad

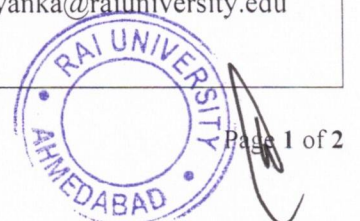
In accordance with the UGC "Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009" to prohibit, prevent and eliminate the scourge of ragging including any derogatory conduct by any student or students, the constitution of the **Anti-Ragging Squad (ARS)** is as follows:

Roles of Squad:

1. The Squad will promptly intervene in any suspected or reported incident of ragging in campus.
2. The Anti-Ragging Squad will conduct regular and surprise inspections of classrooms, hostels, mess, canteens, transport facilities, isolated areas, and other vulnerable locations within the campus to prevent any incident of ragging.
3. The Squad will investigate complaints, record statements of victims/witnesses, collect relevant evidence, and submit reports with recommendations to the Anti-Ragging Committee for necessary disciplinary and legal action.
4. The Squad will ensure the safety, dignity, and confidentiality of complainants and victims of ragging, provide immediate assistance and support, and take necessary steps to prevent intimidation, retaliation, or recurrence of such incidents and will operate with fairness, transparency and accountability.
