BETWEEN

Gujarat Knowledge Society (GKS) having its registered office at Directorate of Technical Education, Block No.2, 3rd Floor, Karmayogi Bhavan, Sector - 10A, Gandhinagar-382010, here after referred to as "Technical Education PMU at GKS" as First Party,

AND

Rai University, Ahmedabad Located at SH144, Saroda, Gujarat 382260. herein after referred to as "Rai University, Ahmedabad" as Second Party,

Whereas,

- i. GKS is the State Project Management Unit (SPMU) and the Technical Education PMU for implementation of the **Student Startup and Innovation Policy (SSIP 2.0)** within the State.
- ii. Rai University, Ahmedabad University is a recognised academic / technical / institute engaged in imparting knowledge in various disciplines through its establishment.

The Government of Gujarat under SSIP 2.0 had a vision to Empowering the young population of the State to unlock their creative potential through Start-up and Innovation to enable them to contribute for sustainable development and inclusive growth towards the realization of Aatma Nirbhar Gujarat.

For effective implementation of SSIP 2.0 and to achieve its goals and objectives the Technical Education PMU at GKS agrees for **conditional disbursement of grant** to Rai University, Ahmedabad wherein Rai University, Ahmedabad agrees to contribute under following:





1. Goals and Objectives of SSIP 2.0:

- a) Outreach and sensitize 5 million students for innovation and entrepreneurship, covering at least 1000 Higher Educational Institutions (HEIs) and 10,000 Schools of the State.
- b) Support to 10,000 student-led Proof-of-Concepts (PoCs/Prototype).
- c) Assistance to 5000 IP filings.
- d) Build capacity for at least 500 educational institutions and universities in the State, to have a robust preincubation support system for beneficiaries.
- e) Nurture 1000 school student led innovations.
- f) Groom 1500 student Start-ups and upscale existing Start-ups.
- g) Incubate 500 Start-up (physical and virtual).
- h) Support to 500 Start-up under Start-up Srujan Seed Support (Up to INR 10 Lac).

2. Rai University, Ahmedabad agrees to pursue following interventions:

- a) Utilization of fund allocated to develop pre-incubation facilities and assist students in IP filing, developing PoCs, prototypes and other innovation related activities.
- b) Formation of committees to scrutinize and evaluate PoC/Prototype and IPR proposals.
- c) Systematic mechanism for creating awareness, outreach, and development of infrastructure.
- d) Selection of proposals for PoCs/Prototype and IPR.
- e) Ensure grant disbursements within 45-60 days.
- f) Ensure the entire PoC/Prototype/IPR grant be disbursed in maximum 2-3 instalments based on the progress.
- g) Implement and operate digital interface to create face-less and paperless mechanism for disbursement of grants.
- h) Strengthen mentorship programme with industrial expertise.
- i) Leverage other schemes and programmes at state and central level designed for Innovation and Start-up.
- j) Exposure and participation for flagship programmes at national and international level.
- k) Promote innovation and Start-ups by women, especially abled, marginalized community and those innovators trying to address persistent challenges of the State and the Nation.
- Any dropout from school / institute / university can avail the PoC/Prototype/IPR support by registering as the Policy beneficiary at educational institution level.
- m) Ensure the active participation of student beneficiaries in the PoC/Prototype/IPR for which the grant has been sanctioned.

- n) Rai University, Ahmedabad to support exposure to tinkering lab, Innovation Lab, Incubation Centres, large Scale sensitization, events, and programs for developing scientific mindset, collective/community level support system and activities and capacity building.
- o) Rai University, Ahmedabad to support to Maximum INR 2.50 lakh per PoC/Prototype/Innovation.
- p) Rai University, Ahmedabad to support 100% expenses of IP
- q) Rai University, Ahmedabad shall create IP facilitation cell (IPFC) under the guidance of State level IP facilitation cell at i-Hub.
- r) Rai University, Ahmedabad shall participate and comply to the state level interventions as given in Section 4.1.1 of SSIP 2.0 G.R. No. PRC/102021/SSIP2.0/934/S, dated 4th January 2022.

3. Terms and Conditions of the grant/funding:

- a) Rai University, Ahmedabad would be provided a total financial support in the form of Grant-in-aid of Rs.3Lakhs. (Rupees in Words) for one year, which would be exclusively spent on the specified purpose for which it has been sanctioned within the stipulated time.
- b) The grant-in-aid would be spent as per the approved action plan included in the MoU and mutually agreed to in consultation between GKS and Rai University, Ahmedabad
- c) Rai University, Ahmedabad shall maintain a separate interest-bearing bank account for the funds to be disbursed by the Technical Education PMU at GKS. The Rai University, Ahmedabad will have to deposit the Grantee Matching Fund (GMF) in the account and upload the credit entry on the digital portal. Verifying the same, the SSIP 2.0 grant will be credited by the Technical Education PMU at GKS. The interest earned on the grant money, would be reported to the Technical Education PMU at GKS and the same will be refunded to Gujarat Knowledge Society.
- d) The amount sanctioned during the first instalment will depend on the proposed and agreed expenditure as per the budget plan submitted by Rai University, Ahmedabad.
- e) Rai University, Ahmedabad shall register itself with Controller General of Accounts (CGA) and the Comptroller & Auditor General of India (CAG) at its discretion shall have the right to access the books of account for the grant received from the Government under SSIP 2.0.
- f) Rai University, Ahmedabad will be required to submit Chartered Accountant certified Utilisation Certificates (UCs) with UDIN number of the grant at the end of each financial year as well as at the time of seeking further instalments of the grant, if any.

Any unspent balance amount sanctioned by GKS would be either adjusted towards the grants-in-aid payable during the next

- instalment or refunded to the Govt. of Gujarat by means of an Account's Payee Demand Draft drawn in favour of "Gujarat Knowledge Society" payable at Gandhinagar.
- h) All the assets acquired or created out of the grant will be the property of the Govt. Of Gujarat and should not be disposed-off or encumbered or utilised for purpose other than those for which the grant has been sanctioned without the prior authorization from GKS.
- i) Rai University, Ahmedabad agrees to comply with guidelines issued by the Technical Education PMU at GKS, Govt. of Gujarat from time to time for utilization of SSIP 2.0 Grant.
- j) Rai University, Ahmedabad abide to follow rules and regulation as mentioned in SSIP 2.0 G.R. No. PRC/102021/SSIP2.0/934/S, dated 4th January 2022 and Policy implementation Committee (PIC) or State-Level Apex Committee (SLAC) of SSIP2.0 in all circumstances.
- k) Rai University, Ahmedabad agrees to implement all the pedagogical and academic interventions as may be suggested form time to time by State Level Committee for SSIP 2.0 Gujarat.

4. Obligations of Rai University, Ahmedabad:

a) Rai University, Ahmedabad agrees to accomplish proposed milestones as per its application for SSIP 2.0 grant; that are listed below:

- c) Rai University, Ahmedabad agrees to evolve a transparent system for selection of innovative ideas/projects to be supported.
- d) Rai University, Ahmedabad agrees to enter into an appropriate agreement with the inventor within framework of policy and guidelines given from time to time by the Technical Education PMU at GKS, Government of Gujarat.
- e) Rai University, Ahmedabad agrees to invest sufficient additional amounts in promoting startups and innovation eco system in the institute.
- f) Rai University, Ahmedabad would provide the physical infrastructure/civil work necessary for implementation of the above.
- g) Rai University, Ahmedabad agrees that no civil work / construction and similar activities will be carried out from the funds provided by the Technical Education PMU at GKS under SSIP 2.0.

5. Monitoring and Evaluation:

- a) The Technical Education PMU and the Operational PMU may review or / and scrutinize the fund utilized by the Grantees or Beneficiaries for the disbursed funds.
- b) The evaluation of performance of PMUs and Grantees would be done in agreement with implementation guidelines that will be released by the Technical Education PMU.
- c) A digital interface will seamlessly integrate all stakeholders to monitor each milestone in real time. Progress of key goals with respect to set KPIs will be publicly shared periodically.
- d) The Policy Implementation Committee (PIC) shall review overall policy objectives and its implementation.
- e) If a beneficiary is found unable to deliver the desired outcomes, further release of grant shall be reconsidered.
- f) The release of the grant after the first instalment and every subsequent instalment will be based on satisfactory implementation of the policy objectives.
- g) Expert Committee comprising of industry persons, ecosystem stakeholders, academicians, Start-up, nominated by the Technical Education PMU may visit Grantees periodically for ascertaining progress of work or resolving any difficulties if encountered for effective implementation of the Policy.
- h) A yearly impact report of the policy interventions will be published and shared with all stakeholders in public domain.

6. Termination of Support and Penalty:

- a) The GKS, Government of Gujarat, reserves the right to terminate support to Rai University, Ahmedabad at any stage under SSIP 2.0, if it is convinced that the grant is not being utilized properly or that appropriate progress to achieve objectives of SSIP 2.0 are not being made. The entire amount will be treated as a sunk investment and the assets acquired through the grant will be written-off by the Technical Education PMU at GKS.
- b) Rai University, Ahmedabad agrees to repay/refund grant received under SSIP 2.0 with interest from the date of disbursement if the Technical Education PMU, Government of Gujarat is convinced that the grant is not being utilized for the purpose mandated by SSIP 2.0, the Technical Education PMU, Government of Gujarat, reserves the right to recover any such amount.

c) GKS can recover any such amount through the revenue recovery process of the government.

7. Grievance redressal Mechanism

In case of any ambiguity or difficulty or query concerning interpretation and/or implementation of the Policy, the decision of Policy Implementation Committee (PIC) with the approval of the State-level Apex Committee (SLAC) shall be final and binding for all.

8. Validity of the MoU

The validity of the MoU starts from the date of signing till **the period of the Policy (March 31, 2027)**. The Technical Education PMU at GKS holds all rights to terminate the MoU if the educational institution fails to deliver its performance as per the action plan. This performance will be measured and monitored by the respective PMU. The MoU will be valid from the date of signing and it will be reviewed every year.

9. General Conditions

- a) Rai University, Ahmedabad agrees to accommodate any changes that are made in the plan of action from time to time for the implementation of SSIP 2.0, Government of Gujarat.
- b) It is mandatory to acknowledge the SSIP 2.0 support in all appropriate fora, in media (both electronics and print), website, annual reports, publicity material, etc. in a visible manner.
- c) The MOU can be modified or revised from time to time with mutual consent of both the parties.
- d) The MOU must be supported with the following documents:
- e) Copy of affiliation letter to Rai University, Ahmedabad by statutory body.
- f) Legal authority letter in the name of person who is signing MoU on behalf of University/Institute/ College.
- g) Rai University, Ahmedabad undertakes to follow the direction of the government/ executive body of SSIP, issued under the SSIP with respect to implementation of the policy and the action plan.

Each of the undersigned signatories represent and warrant that he/she is authorized to execute this arrangement on behalf of the party for whom he/she sign and that no further authority or execution by any other person for such party is necessary.

BETWEEN

Gujarat Knowledge Society (GKS) having its registered office at Commissionerate of Technical Education, Block No.2, 3rd Floor, Karmayogi Bhavan, Sector -10A, Gandhinagar-382010, here after referred to as "GKS" as First Party,

AND

Rai University, located at Saroda, Dholka Taluka, Ahmedabad, Gujarat - 382260, Gujarat, INDIA herein after referred to as "RAI UNIVERSITY" as Second Party,

Whereas,

- GKS is a recognised nodal agency for implementation of the Student Startup and Innovation Policy (SSIP) of Government of Gujarat.
- ii) RAI UNIVERSITY is a recognised University establishment under the Act of Gujarat Legislature known as Gujarat Private Universities Act, 2009 (Gujarat Act no. 12 of 2012) and is engaged in imparting knowledge in various disciplines through its establishment.

The Government of Gujarat under SSIP aims to create an integrated, state-wide, university-based innovation ecosystem to support innovations and ideas of young students and provide a conducive environment for optimum harnessing of their creative pursuit through GKS. For effective implementation of SSIP and to achieve it's objectives (as listed below) GKS agrees for conditional disbursement of grant to RAI UNIVERSITY; wherein RAI UNIVERSITY agrees to do following:

- g. Leverage public system initiatives at state and central level, academia, industries and by other ecosystem stakeholders/domain experts and institutions to make an inclusive effort.

2. RAI UNIVERSITY agrees to pursue following interventions:

- a. The university shall set up a basic facility in form of a student innovation and entrepreneurship council, employ human resources to look after the council, assign a senior competent authority for coordination of such a facility at university level to develop action agendas for short and long term and share the same with the state.
- b. Create action plan and strategies to support startups, and processes to help them. Undertake a holistic approach and create systems to support ecosystem, process, start ups with inclusion of sectors and spaces.
- c. Student startup manuals like tool kit development which will be handy for support teams and institutes/universities to comply to basic necessary requirements which will be handy to give them best possible handholding across startup value chain.
- d. Create suitable open innovation models to create more student innovators and startups, recognise and reward them. Institutionalise innovation and student startup awards.
- e. Creating a funnel to support ideas at prototype stage by creating pre-seed funds / grants.
- f. Ensure bare minimum exposure for students on how to solve problems, innovate and start up in college.
- g. Through various research grants and other ways, students will face the much needed challenges. These challenges will be based on local and global issues. The university is also to encourage students to build products, services, solutions and convert those to enterprise for value creation.
- h. Developing a suitable and flexible protocol for student innovators to leverage existing infrastructures, mentors, testing facility, operational space etc. across universities of Gujarat after regular class hours. Also create networking opportunities for students among different internal and external stakeholders.
- i. The university will categorise and prioritise interventions which may range from low-cost intervention, medium-cost intervention and others.
- j. Create processes and mechanisms so that the scope of accessing facilities and benefits can reach student innovators and idea-stage startups, with equal ease on merit basis. Innovate to reduce transaction time and cost to facilitate support and access to various infrastructures to startups while leveraging existing facilities in Government and/or private domain.

c. Create IPR centre.

3. Terms and Conditions of the grant/funding:

- b. The grant-in-aid would be spent as per the approved action plan included in the MoU and mutually agreed to in consultation between GKS and RAI UNIVERSITY.
- c. RAI UNIVERSITY shall maintain a separate interest-bearing bank account for the funds to be disbursed by GKS. The interest earned on the grant money, would be reported to GKS and the same will be treated as a credit to RAI UNIVERSITY to be adjusted towards further instalments of the grant.

- e. The Comptroller & Auditor General of India (CAG) at its discretion shall have the right to access the books of account for the grant received from the Government under SSIP.
- f. RAI UNIVERSITY will be required to submit CA certified Utilisation Certificates (UCs) of the grant at the end of each financial year as well as at the time of seeking further instalments of the grant, if any.
- g. Any unspent balance amount sanctioned under SSIP would be either adjusted towards the grants-in-aid payable during the next instalment or refunded to the Govt. of Gujarat by means of an Account's Payee Demand Draft drawn in favour of "Gujarat Knowledge Society" payable at Gandhinagar.
- h. Grant to the institute/University to be utilized under the scope of SSIP policy mandate.
- i. RAI UNIVERSITY agrees to introduce at least one course with project-based component in every semester in its curriculum starting from first semester itself.
- j. RAI UNIVERSITY agrees to introduce one course on entrepreneurship and design thinking and problem identification in the beginning of the course programme.
- k. RAI UNIVERSITY agrees to implement all the pedagogical and academic interventions as may be suggested from time to time by the State Level Committee for SSIP, Gujarat.
- 1. RAI UNIVERSITY agrees to revise its curriculum not more than every three years.
- m. RAI UNIVERSITY agrees to comply with guidelines issued by SSIP-GKS, Govt. of Gujarat from time to time for utilization of SSIP Grant.
- n. RAI UNIVERSITY agrees to make expenditure, for SSIP related activities, initially from institute resources on reimbursement basis. The same shall be reimbursed through SSIP grant after verification, if found in conformity with grant utilization guidelines issued by SSIP Cell, GKS from time to time

2. For the expenses under above listed budget heads, delegation of financial power shall be as follows:

- Expenditure up to Rs. 50,000/- can be approved by the University/Institute head.
- Expenditure more than Rs 50,000/- & less than Rs. 200,000/- can be approved by the University level SSIP committee.
- Purchases should be made by inviting competitive offers only.
- For single Expenditure more than Rs. 200,000/- Open tendering process should be adopted.

3. Expenditure guidelines for the projects that are granted support for PoC/Prototyping:

- a) The University Level SSIP Scrutiny Committee shall decide on the project to be taken up for support. Not more than Rs 2.50 lakh should be sanctioned for each project. However, if the nature of the project demands so, a higher amount can be recommended by the Rai University for decision to the State Level Committee.
- b) The Innovator team shall submit a monthly report to the committee through the mentor/team leader and, also update the same on the State SSIP 2.0 MIS Portal/Cogent Portal and support should be continued only if satisfactory progress is being made.
- c) The PoC grant sanctioned by the SSIP committee of the University/Institute to the students/innovators team is as an assistance to the students/innovators. The number of instalments and the quantum of each instalment should be finalized by the SSIP Committee of Rai University. However, the number of instalments should not exceed three.
- d) A format of Utilization Certificate as attached at Annexure-I herewith should be signed by the faculty mentor and submit to SSIP Coordinator, Head of department, and Head of Institute, certifying that the amount spent by the students/innovators are for the stated purpose.

4. IPR guidelines:

- a) IPR cell/ centre to process the information and shall get internal approvals of the University Level SSIP Scrutiny Committee.
- b) The Innovator may be provided help from a consultant to apply for IPR. Only DIPP recognized consultants can be assigned IPR related consultancy work at DIPP approved rates.

- c) IPR cell/centre must follow up with the status of the applications.
- d) In case any queries/ objections are raised against the application, the IPR cell/ centre in consultation with the innovator/ creator/ applicant must facilitate a suitable response.
- e) Once the registration certificate is obtained, the IPR cell/ centre must inform about the same to the applicant/ innovator/ creator.
- f) The IPR cell/ centre must facilitate the applicant/ innovator/ creator in promoting the product for commercialization.


