



## MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding is made on this 1<sup>st</sup> day of July, 2022 at Ahmedabad.

### BETWEEN

**Rai University** having its address at SH 144, Village – Saroda, Taluka – Dholka, Dist. – Ahmedabad – 382260, Gujarat (India). (This expression shall mean and include its present office bearers and executors in the interest of educators, administrators and assignees) of the **FIRST PART**

### AND

**KD Hospital**, having its Address at Vaishnodevi Circle, Sarkhej - Gandhinagar Hwy, Ahmedabad, Gujarat 382421 hereinafter referred to as the **KD Hospital** or (which expression shall unless repugnant to the context, be deemed to include its successors, executors, assigns and agents) on the **SECOND PART**

### WHEREAS

1. COLLEGE has approached **KD Hospital** to impart practical training/internship/clinical posting to their Students at **KD Hospital** unit situated in Ahmedabad.
2. Both the parties have decided and entered into this Memorandum of Understanding on the terms as recorded hereinafter.

NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSES AS UNDER:

### Activities:

1. **KD Hospital** will provide practical training and exposure of the machines and equipments. Students will also have to submit a report or projects given by the hospital. Duration of the training will be minimum 2 months with working hours of 8.5 hours.
2. College seek mutual advice and support in planning and executing programs promoting excellence in respective areas of research and education.
3. Encourage the regular / visiting faculty members and officers of either organization to visit other organization for giving talks in lectures/Programmes.
4. Both the parties agree to hold/conduct, whenever feasible, national events, joint workshops, conferences, training programs within the areas of mutual interest.



## Rights & responsibilities of College & their Students

5. College shall notify KD Hospital in writing in advance, i.e. 15 days before proposed training/clinical posting/internship schedule.
6. The College shall be responsible to inform the KD Hospital in case of any changes in decisions regarding training activities such as change in the schedules etc.
7. College shall be responsible to maintain student's personal details including verified contact details and address preferably of a local guardian.
8. Students/Trainees of College shall be strictly bound to follow rules, regulation and policies enforced from time to time by KD Hospital including the right of entry into the premises of KD Hospital.
9. College shall be responsible to provide Identity card to their students and staff members to allow them entry into the premises of KD Hospital.
10. College and its students shall not disclose or use any confidential information, documents and any other hospital policies gained in the course of training period with KD Hospital, for their personal gain or for advantage of any other person. No information shall be provided to any external agency, formally or informally.
11. Student will be responsible to KD Hospital for any financial loss due to any accident, hazards caused to the KD Hospital by the student of College in the premises of KD Hospital.
12. Student shall pay to KD Hospital as agreed herein:

Course Name	Training cost per student ( INR)
Internship of (Respective Department)	Amount varies according to the Department

Internship can be done at KD Hospital.

No student will be permitted to undergo clinical posting if the payment of fee is not received in advance.

All payments to be made in favor of "KD Hospital" whether it is about the Fees to be taken.

Fees can be revised in the particular time duration that is the mutual understanding.

## Rights & Responsibilities of KD Hospital

1. KD Hospital reserves its right to alter, reject or change the training schedules to safeguard the interest of Hospitals, its patient etc.
2. If number of breach of rules of the KD Hospital by students collectively exceeds five, KD Hospital shall inform the same to College and KD Hospital shall have right to terminate this arrangement with immediate effect.

**TERM PERIOD & MISCELLANEOUS**



1. This Memorandum of Understanding (MOU) will remain in force for a period of 3 (Three) years effective from date of signing of this MOU unless either party terminates the same by giving 30 days prior written notice. Without prejudice, KD Hospital reserves its right to cancel this memorandum of Understanding in the event it is found that College or any of its students have acted contrary to the obligations contained in this Memorandum of Understanding. The decision of KD Hospital in such cases, shall be final.
2. Both the parties shall use each other's trade (brand) name/logo so as to indicate their association with them subject to taking prior written approval from each other.
3. No modification, variation, waiver or amendment of any term or condition of this agreement shall be effective unless and until it shall be reduced to writing and signed by both the parties thereto.
4. The signatory of this MOU is having a requisite authority under the construction of the respective organization to execute this MOU.

**Arbitration & Jurisdiction**

1. Any dispute arising out of this MOU shall be mutually resolved first and if required it may be referred to common arbitrator appointed by the parties to resolve the same.
2. Any dispute, differences, controversies or claims arising out of or relating to this MOU are subject to exclusive jurisdiction of Courts at Ahmedabad only.

The parties here to set and subscribe their respective approval on the date mentioned above.
