BETWEEN

Rai University and Rapture Biotech International Private Limited recognized that mutual collaboration, given each other's strengths in research and facilities thereof, will mutually benefit the Students, Research Scholars and Faculties of Rai University and the Scientists and Researchers of Rapture Biotech International Private Limited.



Now therefore the parties hereto have agreed to enter into a Memorandum of Understanding (MoU) considering the long term benefits of sharing the knowledge between the Organizations and establish a vibrant academic-industry collaboration, by undertaking joint activities in their respective fields of research, as below (hereinafter referred to as " Activities").

It is mutually agreed by and between the parties as under.

1.0 Activities

- I. Seek mutual advice and support in planning and executing programs promoting excellence in respective areas of research and education.
- II. Encourage the regular / visiting faculty members and scientists of either organization to visit other organization for giving talks in lectures/Programmes.
- III. That the faculty/staff, research fellows registered for Ph.D. degree and Students may visit the other institution for a short period in connection with their research work under joint collaboration program.
- IV. Selected students of U.G, P.G. and PhD in the respective areas of specialization of University will be allowed at a time for project work at Rapture Biotech International Private Limited.Students will work in the areas of mutually agreeable areas identified by the both organizations.
- v. Both the parties agree to hold/conduct, whenever feasible, national events, joint workshops, conferences, training programs within the areas of mutual interest.
- vi. To exchange faculty/technical personnel on fulltime/part time basis for a limited period not exceeding one year at a time for the purpose of implementation of joint tasks within the areas of co-operation on mutually agreed terms and conditions



2.0 Co-ordinating Committee

There will be a co-ordinating committee consisting of Registrar - Rai University and Director -Rapture Biotech International Private Limited and if necessary, two additional members from each organization who will be responsible for the effective implementation of the MoU.

If any charges / expenses are to be paid by either organization for the facilities provided by the other organization, such will be decided by co-ordinating committee by a separate 'Rentals and Services Agreement' which also may be modified from time to time as per the need.

3.0 Disclosure

Rai University and Rapture Biotech International Private Limited on their respective website and business communications, make a mention of this research collaboration. Any referred communication will be sent for review and approval by the co-ordinating committee.

4.0 Secrecy

It is hereby agreed that Rai University and Rapture Biotech International Private Limited shall keep information and data collected completely secret.

5.0 Duration

The MOU is valid for a period of 60 months from date of signing.



6.0 General

The agreement can be modified from time to time, if necessary, based on mutual agreement.

7.0 Termination

Both the organizations are free to terminate the agreement by giving a notice of 6months.
